TEAM CAPTAINS - MEN'S AND LADIES LEAGUES

WINTER 2011 / 2012

Each team will consist of two pairs who must play in strict order of merit. Matches should be played as follows, with the visitors remaining on the same court:-

<u>1st Round</u>	<u>2nd Round</u>
Home 1 vs Away 1	Home 2 vs Away 1
Home 2 vs Away 2	Home 1 vs Away 2

DIVISIONS PREMIER, A, B, C, D, E, F, G, H, I, J and K

MATCHES MUST BE PLAYED ON THE FIXED DATE AS SPECIFIED. Matches may only be played on an alternative date at the discretion of the organiser, or if any member of the team is selected to play for their County or Country.

ALL OTHER DIVISIONS

Matches must be played on one of the three dates offered by the Home Team, one of these dates being the round date, and the other two being prior to the round date.

ANY EXTENSION TO THE ROUND DATE MUST BE AGREED WITH THE LEAGUE ORGANISER.

Each rubber will be the best of 3 sets, with a tie-break at 6 games all in the first 2 sets.

THE THIRD SET TO BE A CHAMPIONS TIE-BREAK, FIRST TO 10 POINTS WITH A 2 POINT ADVANTAGE.

Match cards should be downloaded from the website as instructed and taken to the match.

POINTS = 2 Points for win, 1 Point each for draw (on Rubbers)

3rd set winners will score 1 set (Sets score) and 1 game (Games score).

2 Points awarded for walk-over. No points deducted for match conceded.

A match conceded will result in all rubbers being recorded as 6-0,6-0 to the team receiving a walk-over.

Each team will consist of two pairs who must play in strict order of merit. Matches should be played as follows, with the visitors remaining on the same court:-

1st Round

Home 1 vs Away 1

Home 2 vs Away 2

2nd Round

Home 1 vs Away 2

Home 2 vs Away 1

Matches must be played on one of the three dates offered by the Home Team, one of these dates being the round date, and the other two being prior to the round date. Dates shown are week-commencing Monday, day of week at discretion of Home Team.

Matches must be played on either mid-week mornings or afternoons.

Each rubber will consist of TWO 6-ALL TIE-BREAK SETS.
