# 1. Chair's welcome

The Chair of Tennis Scotland, Mr Graham Watson, welcomed those attending the Annual General Meeting of Tennis Scotland. The Company Secretary announced that there had been a total of 40 proxies received by the deadline of 18 April 2023. These proxies more than fulfilled the quorum for the business proper of the AGM to be conducted. There was also a total of 4 voting cards in the room and hence a total of 44 votes for the 2022 AGM resolutions.

# 2. Apologies for absence

Formal apologies for absence had been received from Sheena Sim, John Stevenson, and Deborah Hood. In addition, 19 notes of non-attendance per Appendix 6 of the AGM papers had been received.



## 3. Approval of 2021 AGM minutes dated 21 April 2022

The Chair requested that the minutes of the Tennis Scotland Annual General Meeting dated 21 April 2022 (which had been previously circulated with the notice calling the meeting) be approved. The minutes were duly approved with no amendments noted.

## 4. To receive the report of the Chair

The Chair, Mr Graham Watson presented his report to the meeting;

"It is pleasing to see the continued growth of tennis in Scotland – membership has increased from 57,000 to 75,000 in the past 5 years, with an accompanying increase in revenue from £1.8m to £3.1m.

Many people are responsible for this growth – our members, volunteers, sponsors, key partners – sportscotland and the LTA – and of course the staff of Tennis Scotland. To all, I offer the thanks of the board for their support of our long-term vision of *'tennis opened up to deliver the legacy in Scotland'*.

The governing body is fortunate in having such a strong executive team, led so professionally by Blane. It is all too easy to take for granted the work that goes on every day to grow the sport here is Scotland, and too often we can forget how many people go above and beyond their day-to-day responsibilities to deliver the outstanding results that Blane will speak to in a few minutes.

It is exciting to see building progress on the combined £6m development of new indoor facilities in Edinburgh and Moray, supported by the TSIT fund, as well as progress in investing the public parks regeneration funding.

However, it is disappointing that the very successful GB National Tennis Academy here in Stirling will be moving south of the border. Nevertheless, as we transition from hosting the GB National Academy, we expect the LTA will wish to continue supporting a new Scottish focused National Player Performance Pathway with significant investment.

We were delighted that the recent audit of the governance arrangements of Tennis Scotland, conducted by KPMG on behalf of sportscotland, delivered the highest possible level of assurance.

As you would expect, the board exercises close governance over the finances of Tennis Scotland, but as the accounts for last year show, it is increasingly challenging to deliver a break-even outcome, let alone generate surplus for future investment.

So, while terrific progress is being made in growing the sport, there are a few darker clouds on the horizon. The fragile economic situation and stretched public finances mean that our funding from the LTA and sportscotland is not growing as we would wish, and not at a level commensurate with the growing demand we are seeing across Scotland. Equally, despite the valuable support of existing sponsors, market conditions and external restrictions make it difficult to recruit major new partners.

Existing funding arrangements are insufficiently flexible to enable agile management of an ever-changing environment.



Slower investment of the TSIT fund than we would like – largely due to the inability to find private sector partners willing to invest on the terms demanded by the fund - is evidence of this inflexibility.

Looking to the future therefore, a priority and responsibility for the Board is to examine all options that will enable us to fund continued growth of the sport in Scotland. As these discussions progress and conclude, we will of course keep the membership updated on our thinking.

Thank you again for attending the AGM and for your continued support of Tennis Scotland. I will now hand over to Blane to present the annual report and accounts. If I may, I will suggest that you leave questions on Blane's presentation until the conclusion of his remarks."

# 5. To receive the Annual Report of Tennis Scotland for the year ended 31<sup>st</sup> December 2022

Blane Dodds, the Chief Executive, presented the 2022 Annual Report with the aid of a PowerPoint presentation. The Annual Report will be distributed to all members following the AGM. A summary of the key areas covered included;

- Facilities; Club membership from 57,494 in 2018 to 74,560 in 2022, 257 new coach qualifications completed, 507 School teachers trained in LTA Youth Schools. Increasing the number of covered indoor tennis courts. Improved Park tennis provision
- Participation; Davis Cup success in September 2022; 83 Schools involved, 2,584 children attended, 295 sports leaders trained in advance, 16 Open Court disability venues
- Participation; Billie Jean King Cup Tennis Scotland profiled female participation and workforce, 2870 tickets made available to schools, 70 schools took advantage of free schools tickets and a transport grant
- Community; Opening tennis up in Scotland; SERVES changing lives with tennis in Scotland, Rackets Cubed, Tennis4RAD (Race Against Dementia)
- Workforce; coach education and CPD courses attended by a huge number of coaches and coach qualifications achieved. Spotlight on Tennis Scotland Apprentices, Luke Turnbull, Katie McKay, and Euan Donegan
- Disability & Inclusion; 25 active open court disability venues, 59 entries for Scottish Closed and LTA Regional disability tournament at Newlands. 2023 target for 25+ open court venues to be funded by Tennis Scotland
- Educational Activities; Teacher Training, Schools events and competitions, University partnerships, Tennis Scotland Schools roadshows fund
- Performance; Scottish Player Pathway/ Scottish National Academy process and outcomes
- Performance success; Gordon Reid, Cameron Norrie, Andy Murray, Jamie Murray
- Performance 14+ players; Matt Rankin, Charlie Robertson, Ben Hudson, Jack Deveney, Ellie Robertson
- Performance doubles spotlight, Ali Collins, Maia Lumsden, Scott Duncan, Jonny O'Mara, Connor Thomson, Jacob Fearnley
- GB National Tennis Academy highlights: 19 Junior ITF titles won by GBNTA players, 3 players represented Team GB, 4 GB NTA players gained straight 'A' Grades
- Competitions: 6,210 competing players, 148 local tour events delivered, 230 LTA matchplays delivered, 861 total Grade 5 and 6 events, 4 World tennis tour events delivered



- Media communications: 248 pieces of coverage across the 12 months. Key announcements included; Tennis Scotland Awards, TSIT, US Open trophy tour, Davis Cup and Billie Jean King Cup. TSIT £1.63m and £4.5m funding for indoor courts in Moray and at Oriam respectively. Social Media – Twitter +337 to 9,654 followers, Instagram + 654 to 5,072 and Facebook + 360 to 12,014
- Finance: Tennis Scotland accounts for 2022 showed an increase in turnover of £786k to £3.125m, a small deficit of £37k made for the year to 31 December 2022 with reserves remaining stable at £471k.
- Strategy 2022 2026: Vision "Tennis Opened up to Deliver the Legacy in Scotland". Develop, Ambition, Culture, Strategy for 2023. Looking ahead the priority areas being Padel, Facilities, Capacity building – retention and growth, Scottish National Performance Pathway, Performance Players, Commercial, Culture development, District Review, Resource development, Position TS, Political engagement, Maximize outcomes for all.
