

# **LTA YOUTH SCHOOLS - VOUCHER SCHEME - TERMS & CONDITIONS**

## **£250 VOUCHER**

### **School eligibility:**

- Following attendance at an LTA Youth Schools Teacher Training Course, the LTA will provide schools with access to a £250 digital voucher.
- The voucher is restricted to one voucher per school, regardless of how many teachers from a school attend the LTA Youth Schools Teacher Training Course.
- Schools which cater for children within the 4-11yrs old boundary (i.e. primary, infant, junior schools) or the 11-16yrs old boundary (i.e. secondary, junior, senior) are eligible to receive the voucher.
- Schools can select to redeem the voucher for either 10 hours of team teaching with an LTA Accredited Coach or tennis equipment.
- The voucher is made available to eligible teachers via the LTA Youth Schools portal.
- The voucher can only be redeemed once.
- No cash alternative is available.
- The voucher will expire on 31<sup>st</sup> December 2025.

### **10 hours Team Teaching Option**

#### **Voucher usage:**

- The voucher must be used to access 10 hours support for the school with a local LTA Accredited Coach, who has been trained on the LTA Youth programme.
- Under no circumstances can coaches who do not hold current LTA Coach Accreditation, or coaches who have not been trained on the LTA Youth programme deliver the 10 hours support linked to this voucher.
- It is the school's choice to select their preferred coach from the list provided and based on the criteria above.
- Once contact is made with the chosen coach, the school is then entering into a separate agreement with the coach. The school must lead on the communication arrangements; the LTA is unable to get involved with individual discussions.
- The 10 hours support must be jointly planned, between the school and the coach, in a way that maximises the number of children and staff that will benefit.

- The school and preferred coach must agree in advance on the delivery timings for the 10 hours support e.g. 1 hour per week for 10 weeks, or, 1 hour per day for 2 weeks etc.
- The 10 hours support must be delivered within curriculum time.
- The 10 hours support must be based on LTA Youth Schools programme content.
- The 10 hours of support is designed to provide further CPD opportunities for school staff and therefore, the class teacher should be present during each session that the coach delivers.
