Minutes

1. <u>Welcome and Apologies for Absence</u>

David Rawlinson welcomed everyone to the meeting, including 12 new proposed Councillors observing the meeting.

2. <u>Declarations of Interest</u>

3. <u>Minutes of the Meeting held on Wednesday 5 October 2022</u>

The minutes of the meeting held on Wednesday 5 October 2022 were agreed as a correct record.

4. <u>Matters Arising</u>

There were no matters arising not covered on the agenda.

5. <u>LTA President's Report</u>

The President's Report included in the Council papers was taken as read. The President informed the meeting that all Councillors would be expected to move to using their LTA email addresses as their primary means of receiving and sending communications, with more information on this to come in the New Year. In addition, the President advised that all those who were new to Council in 2023 would be asked to give a short introduction at the March Council meeting.

6. LTA Chairman's Report

7. LTA Chief Executive's Update

The Chief Executive's business update included in the Council papers was taken as read.

Scott Lloyd expanded on a number of items from his business update which included noting that: participation monthly play trends were at an all-time high; the Active Lives children and young people survey results were still being analysed but showed signs of growth; nearly all of the LTA's 5-year plan targets had been met a full year early; the success of opening Nottingham Tennis Centre and launch of LTA Tennis Foundation and most recently the news that The cinch Championships at The Queen's Club has been awarded ATP 500 Tournament of the Year at the annual ATP Awards.

9 Development Tennis Advisory Group ("DTAG") Update

9.1 DTAG Workstreams – summary of 2022

Verbal updates from each of the DTAG workstream leads were provided. Highlights included: World Tennis Number update – outstanding competition results have been uploaded; increased numbers on volunteer Facebook group; and only 72 level 2 coaches had not yet gone through the accreditation process, which was now a mandatory requirement for coaching at any registered venue.

9.2 DTAG Workstreams - overview of 2023

The update on the activities of the DTAG and its 2023 workstreams included in the Council papers was noted. A copy of the presentation would be circulated after the meeting. Nigel Jordan noted that current work was being undertaken to decide upon the focus areas/topics for workstreams to ensure continuity and consistency from 2022. He noted that communications would now be a separate workstream and that county governance and funding and inclusion had now been merged.

Nigel Jordan noted that all Voting Council Members would receive an email to express their preferences in joining a workstream with a deadline to complete by Monday 19 December 2022.
