2 The Minutes of the 48th Annual General Meeting

4 Report of the Council for 2022

(Paper 2)

Mrs Windmill outlined the highlights from 2022 including 33 GB World Championship Team and Individual medals; live streaming of the National Club League Finals from the National Tennis Centre for the first time; a post pandemic return to a full programme of the LTA National Seniors County Cup and Four Nations; the ITF Tournament Recognition Award for the Masters 700 Indoors at Wrexham (one of only 10 globally) and a Seniors volunteer won the LTA President's Award!

Mrs Windmill also gave tribute to skills and dedication of the Seniors Tennis GB volunteers to improving and promoting Seniors tennis including high level competition and performance nationally and internationally for Over 35 up to and including the Over 90 age group.

Increasing engagement digitally and with high level competitive tennis, further volunteer and financial resource is required – offers to volunteers are always welcome!

Mrs Windmill finally gave thanks to Keith Carder who as LTA representative has supported and advised Seniors Tennis GB over 6 years and Alistair Alexander, an international player, who has given extensive volunteer time as the representative for Wales and in taking on the thankless task of managing the GB kit for almost 100 seniors players representing Great Britain each year.

The 2022 Report was unanimously approved.

5 Treasurer's Report and Accounts for year ending on December 31st 2022 (Paper 3) Mrs Barber outlined the key points from the Treasurer's Report and Accounts noting the clear intention, despite the significantly reduced LTA grant, to continue with GB World player travel allowances without significant impact on the STGB reserves. This will likely mean that, to operate within the finances available, difficult decisions will need to ne made.

The Accounts were proposed, seconded and unanimously adopted.
