

TIPS FOR WRITING A GREAT NOMINATION

This guide is to support you in crafting a compelling nomination for an LTA Award. While there is no single "right way" to write a nomination, following these tips will help you present the strongest possible case for your nominee.

Remember: the judges will only see what you submit – so make it count!

TOP TIPS

- **Be specific**: Use clear, concrete examples to show how your nominee meets the award criteria
- **Provide evidence**: Include statistics, participant feedback, or measurable outcomes to support your claims.
- **Tell a story**: Paint a vivid picture of the nominee's impact. Consider:
 - What was the situation before they got involved?
 - What did they aim to change or improve?
 - What's different now?
 - What sets them apart from others doing similar work?
- **Highlight key qualities**: Show how the nominee has:
 - Made a distinctive contribution that benefits others
 - Demonstrated dedication to voluntary service or made a significant impact in tennis
 - Shown creativity or innovation in achieving lasting results
- **Show influence and leadership**: Demonstrate how the nominee has:
 - Earned the respect of peers and become a role model
 - Achieved sustained success through vision and hard work
- **Avoid vague praise**: Instead of saying "they're an excellent coach," explain *why*—what have they done, and what has the impact been?
- **Be clear and concise**: Keep your writing simple and focused. Use your word count wisely to cover all relevant areas.
- **Make your case**: End with a strong, specific statement about why your nominee deserves recognition.

EXAMPLE EXTRACTS FROM PREVIOUS NOMINATIONS

Lifetime Achievement Award

Coach of the Year

Club of the Year
