2023 SAFEGUARDING RECAP



The Safeguarding Team has had a busy year, completing several projects, investigating cases, advising on safeguarding matters and conducting visits to registered venues.

Here are some highlights of the activities carried out this year:

In 2023, <u>Young Person's Welfare Ambassador</u> (YPWA) was launched, and young ambassadors were trained to enhance safeguarding and raise awareness. Plans for expansion in 2024 and beyond are ongoing, including impact evaluation.

During <u>Safeguarding Awareness Week</u>, The Safeguarding team conducted workshops on case studies, risk assessments, and support visits.

As part of the new safeguarding plan for 2024-2026, an online course for parents attending competitions is being introduced, and officials' online training is being revised.

"Izzey's Story," a successful safeguarding course designed by Professor Jane Reeves, with the University of Kent's Centre for Child Protection had over 400 participants. A new process was implemented by the case team to streamline investigations.
