

## Coach CPD Survey Competition Terms & Conditions

These Competition Terms & Conditions, together with any specific rules or conditions explained or notified by the LTA as relevant to this Competition (a **Competition Notice**) (as displayed on [www.lta.org.uk](http://www.lta.org.uk) or otherwise) apply to entrants completing the relevant action required to be entered into a draw to win a prize described below (the **Competition**).

By entering the Competition (or accepting a Prize), the entrant agrees to be bound by these Competition Terms & Conditions, the LTA Privacy Policy, and, where applicable, the LTA Online Terms & Conditions (each of which can be found at [www.lta.org.uk](http://www.lta.org.uk)). If you do not agree to comply with these Terms & Conditions, the LTA Online Terms & Conditions, or the LTA Privacy Policy you cannot enter the Competition or be awarded a Prize.

### 1 Introduction

- 1.1 This Competition is organised by LTA Operations Limited (the **LTA**) whose address is at The National Tennis Centre, 100 Priory Lane, Roehampton, London, SW15 5JQ.
- 1.2 The LTA reserves the right to cancel or amend the Competition or these Competition Terms & Conditions and to cancel or refuse any individual's entry at any time without prior notice. Any such changes will be posted on the LTA website ([www.lta.org.uk](http://www.lta.org.uk)).
- 1.3 The Competition shall operate a Prize Draw to draw a Prize-Winner (each as defined below) on each of the following dates:
  - (a) 08/01/2027;
  - (b) 09/04/2027;
  - (c) 09/07/2027;
  - (d) 09/10/2027;
  - (e) 09/01/2028;
  - (f) 09/04/2028;
  - (g) 09/07/2028;
  - (h) 09/10/2029;

each a **"Prize Draw Date"**.

The Competition shall run until the final Prize Draw Date ("**Competition Period**").

### 2 Eligibility

- 2.1 Entrants to the Competition must be resident in the UK. Entrants to the Competition must be aged 16 and over. Entrants under 18 years of age must have permission to enter the Competition from a parent or guardian who will have been deemed to have accepted and be bound by these Terms and Conditions. The LTA reserves the right to ask for proof of age or permission. Entries without proof of permission or age will be disqualified.



- 2.2 The Competition shall only be open to LTA recognised coaches or any individuals currently undertaking an LTA coaching qualification.
- 2.3 No employees of the LTA (or members of their families) involved in the administration of the Competition may win the Competition.
- 2.4 The eligibility of any entrant is at the sole discretion of the LTA. If ineligible, entrants will not be entitled to receive a Prize (as defined below), and any Prize awarded may be revoked.

### 3 Entries

- 3.1 To be included in a Prize Draw, entries to the Competition must be submitted by 11.59pm (UK time) on the day immediately preceding a Prize Draw Date. Entries must be submitted in accordance with the instructions and/or requirements (including method and timing of entry) set out in these Terms and Conditions and in any Competition Notice in order to constitute a qualifying entry.
- 3.2 To enter the Competition, entrants must complete a CPD feedback survey provided by the LTA following the completion by the entrant of an LTA online course, workshop or qualification ("**CPD Survey**"), and submit their contact details using the survey form provided.
- 3.3 Each time during the Competition Period that an entrant completes a CPD Survey in accordance with these Terms and Conditions and provides the required details, a new entry will be made for that person into the Competition. However, entrants may only submit one entry per LTA online course, workshop, or qualification that they complete.
- 3.4 Once a valid entry to the Competition has been made, it shall remain an entry for each Prize Draw of the Competition.
- 3.5 Lost, delayed or incomplete entries will not be accepted and the LTA does not take responsibility for entries that are lost, delayed or not received/entered for any reason, and proof of despatch will not be proof of receipt.
- 3.6 Where applicable, entrants confirm that by entering the Competition their entry: (i) includes information that is true, current and complete; (ii) is not obscene, disparaging or critical of any person, offensive, likely to infringe the rights of any third party or is otherwise unlawful. The LTA reserves the right to disqualify from the Competition any entries which contravene, or are found to contravene, any of the criteria set out in this condition 3.6, or are deemed by the LTA to be critical of the LTA (other than through genuine feedback provided in the CPD Survey), or are deemed ineligible by the LTA for any other reason.
- 3.7 Information (including personal information) submitted in an entry will, unless specifically stated otherwise, be used by the LTA in accordance with the LTA Privacy Policy. All entrants agree that if they are a Prize-Winner they will take part in any promotional activity reasonably requested by the LTA. By entering the Competition or accepting a Prize entrants agree to: (i) the use of their name and county being supplied in accordance with Condition 3.8; and (ii) the use of their name, image, entry and any other details and/or materials submitted in connection with the Competition (including, but not limited to, announcing the results of the Competition).
- 3.8 The LTA must either publish or make available information that indicates that a valid award took place and so the LTA will make the names of the Prize-Winners available to anyone

following receipt of an appropriately worded letter addressed to the '*Coach Development Team – CPD Survey Competition*' and sent to the LTA using the address given above, enclosing a stamped addressed envelope. The LTA reserves the right not to respond to such requests if received more than forty five (45) days after the Competition Period. If you are a Prize-Winner and object to your details being made available, please contact the LTA directly at through the email address used to notify you, but please note that the LTA will still be required to provide such information to the Advertising Standards Authority on request.

3.9 Automated, bulk or third-party entries will not be valid.

#### 4 Prize Draw and Choosing the Prize-Winners

4.1 Subject to these Competition Terms & Conditions and unless otherwise stated in the Competition Notice, the LTA shall operate a draw on each of the Prize Draw Dates to select one (1) winning entrant at random (each a **Prize-Winner**) from all eligible entries that the LTA (at its complete discretion) deems to qualify for entry into the applicable draw (each a "**Prize Draw**"). The LTA's decision is final and no correspondence will be entered into.

#### 5 Prize

5.1 Each Prize-Winner shall receive a £200 Amazon Gift Voucher (the **Prize**).

5.2 The Prize is subject to availability and the LTA reserves the right to substitute a prize of equal or greater value. There is no monetary equivalent or cash alternative to the Prize. The Prize is non-negotiable and non-transferable.

5.3 Should any doubt arise as to an entrant's eligibility, the LTA reserves the right to withhold the Prize until such proof of eligibility and identity has been confirmed or if such proof is not produced on request or to disqualify the entrant from the Competition.

5.4 The Prize-Winners will be contacted by the LTA by e-mail as soon as practicable after the applicable Prize Draw Date. The LTA will attempt to contact each Prize-Winner three times. In the event that a Prize-Winner does not respond to the LTA within five days of the third e-mail, the LTA reserves the right to replace such Prize-Winner with another prize-winner. Only the Prize-Winners will be notified.

5.5 The Prize-Winner will be asked to confirm their email address when contacted. The LTA will then send a £200 digital voucher to the Prize-Winner via email. In the event that the Prize-Winner fails to provide such information the LTA reserves the right to replace the relevant Prize-Winner with another prize-winner.

5.6 A Prize-Winner will forfeit the right to the Prize, without compensation or recourse, if he/she does not agree to be bound by these Competition Terms and Conditions and/or does not meet eligibility criteria.

#### 6 General

6.1 Liability. The LTA cannot accept any liability (other than for death or personal injury or other liabilities that cannot, as a matter of law, be excluded) for any damage, loss, costs, expenses or disappointment, whether direct or indirect, caused to or suffered by entrants in connection with the Competition or as a result of a Prize-Winner accepting or making use of the Prize.

The LTA will not be liable if the Prize is unable to be offered or unable to be accepted by the Prize-Winner.

- 6.1.1 If the Competition or any part of it is not capable of running or being completed as planned for any reason, including but not limited to reasons of infection by computer virus, bugs, tampering, unauthorised intervention, technical failures or any other causes beyond the control of the LTA, the LTA reserves the right to cancel, terminate, modify or suspend the Competition without liability.
- 6.1.2 The LTA accepts no responsibility for Competition entries that are delayed or otherwise not successfully completed, regardless of cause, including (without limitation) due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure, of any kind.
- 6.2 Breach. If the LTA have any reason to believe that there has been a breach of these Competition Terms and Conditions, the LTA may, at its sole discretion, reserve the right to exclude an entrant from participating in the Competition.
- 6.3 Law. These Competition Terms & Conditions and any non-contractual obligations connected to them shall be governed by, and construed in accordance with, the laws of England and Wales and the English courts shall have exclusive jurisdiction to settle any dispute which may arise under or in connection with them.
- 6.4 Severance. If any provision of these terms is found to be invalid by any court having competent jurisdiction, the invalidity of that provision will not affect the validity of the remaining provisions of these terms, which shall remain in full force and effect.
